INDEPENDENT ACCOUNTANT'S REVIEW REPORT

To Management
The Sanctuary at Haafsville, Inc.

We have reviewed the accompanying financial statements of The Sanctuary at Haafsville, Inc. (a nonprofit corporation), which comprise the statement of assets, liabilities, and net assets – modified cash basis as of December 31, 2023, and the related statements of revenues, expenses, changes in net assets and cash flows – modified cash basis for the year then ended, and the related notes to the financial statements. A review includes primarily applying analytical procedures to management's financial data and making inquiries of company management. A review is substantially less in scope than an audit, the objective of which is the expression of an opinion regarding the financial statements as a whole. Accordingly, we do not express such an opinion.

Those standards require us to perform procedures to obtain limited assurance as a basis for reporting whether we are aware of any material modifications that should be made to the financial statements for them to be in accordance with the modified cash basis of accounting. We believe that the results of our procedures provide a reasonable basis for our conclusion.

We are required to be independent of The Sanctuary at Haafsville, Inc. And to meet our ethical responsibilities, in accordance with the relevant ethical requirements related to our review.

Based on our review, we are not aware of any material modifications that should be made to the accompanying financial statements in order for them to be in accordance with the modified cash basis of accounting.

NOTES TO FINANCIAL STATEMENTS

NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Organization - The Sanctuary at Haafsville, Inc. (Organization) was formed as a Non-Profit (Non Stock) corporation in the Commonwealth of Pennsylvania on May 28, 2010 for the primary purpose of constructing, owning and operation animal shelter and sanctuary to serve the needs of the Lehigh Valley and nearby areas of Pennsylvania.

Basis of Accounting - The Organization's policy is to prepare its financial statements on the modified cash basis of accounting; consequently, contributions and other revenues are recognized when received rather than when promised or earned, and certain expenses and purchases of assets are recognized when cash is disbursed rather than when the obligation is incurred.

Use of estimates - The preparation of the financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities in the financial statements. Estimates and assumptions may affect disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses. Actual results could differ from management estimates.

Cash Equivalents - The Organization considers all highly liquid investments purchased with maturities of three months or less to be cash equivalents.

Land, Buildings, and Other Property - Purchases of land, buildings, and other property having a useful life of three or more years are capitalized at cost. Depreciation is computed using the straight-line method over the estimated useful lives of the assets.

Revenue Recognition - Contributions are recognized as revenues in the period received. Contributions are considered to be unrestricted unless specifically restricted by the donor.

Income Taxes - The Organization is exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code, except on net income derived from unrelated business activities. At December 31, 2023 the Organization has determined that no income taxes are due for its activities.

Subsequent Events - Management has evaluated subsequent events through November 12, 2024, the date on which the financial statements were available to be issued.
